This is a response to the above action and the Receivers proposed treatment of the Bally Lines, Ltd. Claim.

1. Bally Lines, Ltd. is the beneficial owner of an account with Tech Traders. All agreements and interest bearing promissory notes were executed between Dr. Edward J. Evors representing Bally Lines, Ltd. And Coyt E. Murray representing Tech Traders. As explained to the Receiver, Bally Lines, Ltd. has made several Private Placement Loans to several entities and has received promissory notes in return. Bally Lines, Ltd. is a small private corporation that helps developing companies and has been successful until the action of the C.F.T.C. against Tech Traders one year ago.
2. I agree with the Receiver's accountants figures at this time, however I respectfully request a copy of the Receivers accounting. I have asked for information regarding the accurate amount the Receiver is holding for claimants of Tech Traders trading accounts, bank accounts, and other holdings that have been confiscated. I believe the trading account was in fact producing revenue and no one has shown proof otherwise.

There is a lot of money and lack of use of these funds for over a year and a lot of lives have been affected because of this situation. I wish you would consider allowing Bally Lines, Ltd. to be treated as one entity and resolve this issue.
