Dear CFTC Commissioners:

The New York Mercantile Exchange, Inc. ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of an approved amendment to Supplement No. 2, "List of Licensed Warehouses and Weighmasters" of the Aluminum Futures Contract to be implemented effective Friday, October 14, 2005. The approved amendment changes the mailing address of the R. J. Corman Distribution Center from South Union, Kentucky to Woodburn, Kentucky. The U.S. Post Office no longer operates in South Union, Kentucky. The physical location of the warehouse facility remains unchanged at 444 Hardison Road and the telephone number remains unchanged.
