Dear Mr. Kirkpatrick:

New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") that it plans to modify the NYMEX Brent Futures Market Maker Program ("Program"). The modifications to the Program will become effective on February 1, 2021.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

NYMEX reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff monitors trading in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The incentives in the Program do not impact the Exchange's order execution. Participants in the Program will be selected by NYMEX staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with NYMEX in which each participant will expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

NYMEX certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

# **EXHIBIT 1**

# **NYMEX Brent Futures Market Maker Program**

## Program Purpose

The purpose of this Program is to incentivize market makers to provide liquidity in the product listed below. The resulting additional central limit order book liquidity benefits all participants in the market.

#### Product Scope

Brent Last Day Financial Futures ("BZ") traded on the CME Globex Platform and cleared through CME ClearPort ("Product").

## Eligible Participants

There is no limit to the number of participants that may participate in the Program. Participants may be NYMEX members or non-members.

## Program Term

Start date is February 1, 2018. End date is January 31, 2021 January 31, 2022.

#### Hours

RTH (8AM CST – 1:30PM CST) and ETH (2AM CST – 8AM CST).

#### **Obligations**

Participants in the Program must quote continuous two-sided markets in the Product at designated bid/ask spreads and quote sizes during a specified percentage of the trading hours.

#### **Incentives**

Upon meeting all Program obligations, as determined by the Exchange, participants may be eligible to receive predetermined incentives.

#### Monitoring and Termination of Status

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant has failed to meet the obligations of the Program.
