The Requesting Parties specifically notes that they do not waive in any manner their rights under Section 8(f) of the Commodity Exchange Act to receive a copy of any subpoena or summons for the Confidential Information prior to the Commission's disclosure of such information pursuant to

such subpoena or summons. Finally, the Requesting Parties request that the Commission notify it in the event that the Commission intends to disclose the Confidential Information to Congress or any federal or state governmental agency or department.
