Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(a), Chicago Mercantile Exchange Inc. ("CME"), The Board of Trade of the City of Chicago, Inc. ("CBOT"), New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX") (collectively the "Exchanges") certifies to the Commission a correction to previous announcements regarding CME Globex Pre-Open hours for CME, CBOT, NYMEX and COMEX futures and options on futures contracts (the "Contracts") effective on Monday, February 28, 2022.

The Exchanges previously submitted incorrect CME Globex Pre-Open hours for the Contracts. It should be noted that (with limited exception) the correct CME Globex hours for all CME, CBOT, NYMEX and COMEX futures and options are as follows:

Sunday Pre-Open 4:00 p.m. Central Time/CT; Open 5:00 p.m. - 4:00 p.m. CT Monday – Thursday Pre-Open 4:45 p.m. CT; Open 5:00 p.m. - 4:00 p.m. CT A maintenance period occurs daily from 4:00 p.m. - 5:00 p.m. CT

Additionally, the correction is with regard to previous submissions and that there is no change to the existing and long-term operational practice of the CME Globex Pre-Open hours.

All CME Group trading and clearing hours may be viewed HERE.

The Exchanges reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA") and identified the following Core Principles as potentially being impacted:

 <u>Availability of General Information</u>: The Exchanges will issue a Special Executive Report ("SER") to advise the marketplace regarding the correction. The SER will also be posted on the CME Group website.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchanges certify that the correction complies with the CEA and regulations thereunder. There were no substantive opposing views to this proposal.
