Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following rule amendments effective during the week of February 13, 2023.

On February 16, 2023, the Exchange implemented administrative amendments to certain of the Exchanges' existing Market Regulation Advisory Notices ("MRANs") to update Exchange staff contact information contained therein. These MRANs included: RA2205-5, RA2204-5, RA2203-5, RA2115-5, RA2114-5, RA2113-5, RA2112-5R, RA2111-5, RA2110-5, RA2107-5, RA2105-5, RA1101-5, RA1903-5, RA2001-5, RA2008-5, RA2010-5, RA2012-5, RA2014-5, RA2206-5, RA2101-1, RA2101-2, RA2102-2, RA2105-2, RA2201-2.

Additionally, regarding RA2205-5, in addition to updating Exchange staff contact information, the Exchanges updated Q&A 9 with respect to which no action relief letter from the CFTC Division of Market Oversight is currently applicable. Q&A 9 previously referenced CFTC Letter No. 19-19 which was extended in August 2022 with CFTC Letter No. 22-09. Q&A 9 now accurately references CFTC Letter No. 22-09.
