Pursuant to Section 5c(c) of the Commodity Exchange Act, as amended (the "<u>Act</u>"), and Section 40.6(a) of the regulations of the Commodity Futures Trading Commission (the "<u>Commission</u>" or "<u>CFTC</u>"), ICAP Global Derivatives Limited ("IGDL"), a registered swap execution facility, hereby notifies the Commission that it is self-certifying amendments to its Compliance Manual, as described more fully in the Exhibits attached hereto.
