CONCISE EXPLANATION AND ANALYSIS OF THE OPERATION, PURPOSE, AND EFFECT OF THE PROPOSED RULE AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Eurex Clearing is amending the Price List to support the Eurex EnLight product scope extension for FX derivatives (classic FX futures, rolling spot futures, and options on classic FX futures).

For avoidance of doubt, Eurex Clearing clears the Eurex EnLight service outside the scope of its DCO license, which applies only to swaps. In addition, the Eurex EnLight service is not available to U.S. participants at this time.

Further information regarding the operation, purpose, and effect of the proposed amendments is discussed in the attached Eurex Clearing Circular 025/21, which is appended as Attachment A.

Eurex Clearing has identified the following derivatives clearing organization ("**DCO**") Core Principle as potentially being relevant to the above amendments:

1. DCO Core Principle C (Participant and Product Eligibility): The proposed amendments will comply with DCO Core Principle C because the amendments expand the product scope for a service offering cleared outside of Eurex Clearing's DCO license, and all products cleared by Eurex Clearing under its DCO license will continue to be subject to appropriate standards in compliance with this Core Principle.
