Re: Weekly Notification of Rule Changes Submission Pursuant to Section 5c(c)(1) of the Act and Regulation 40.6 (d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6(d), ICE Futures U.S., Inc. ("Exchange") submits notification to the Commission that, during the preceding week, the Exchange extended the ICE Derivatives Trading Platform maintenance window by 30 minutes Monday through Thursday evenings (from 18:05 - 18:55 ET to 18:05 - 19:25 ET). The Friday night through Sunday night maintenance window will remain unchanged (Friday 18:05 - Sunday 16:30 ET). The revised hours for the maintenance window are posted publicly on the ICE website and a notice to the market was provided prior to the extension. The notice to the market is attached as Exhibit A.

To accommodate the new maintenance window, some ICE Futures Singapore markets that currently pre-open at 07:55 SGT and open at 08:00 SGT will be adjusted as shown below.
