Dear Mr. Kirkpatrick:

Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of the extension of the Volatility-Quoted Options Fee Waiver Program ("Program") through December 31, 2017. The extension of the Program will become effective on July 1, 2017. All other Program terms remain unchanged.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions underlined and deletions ~~overstruck~~.

CME reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, CME staff identified the following Core Principles as potentially being impacted: Prevention of Market Disruption, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. Exchange staff will monitor trading in the Program's products in order to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The Program does not impact the Exchange's order execution. Chapter 4 of the Exchange rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must comply with, and are subject to, applicable regulations and Exchange rules. Additionally, the Program is subject to the Exchange's record retention policies, which comply with the CEA.

CME certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

EXHIBIT 1

Volatility-Quoted Options Fee Waiver Program

Program Purpose

The purpose of this Program is to incentivize participants to build liquidity in volatility-quoted options. The resulting increase in liquidity benefits all participants in the marketplace.

Product Scope

Volatility-quoted foreign exchange (“FX”) options on Euro/U.S. Dollar futures (“EUR/USD”), Japanese Yen/U.S. Dollar futures (“JPY/USD”), British Pound/U.S. Dollar futures (“GBP/USD”), Australian Dollar/U.S. Dollar futures (“AUD/USD”), Canadian Dollar/U.S. Dollar futures (“CAD/USD”), and Swiss Franc/U.S. Dollar futures (“CHF/USD”) that are traded on Globex® (collectively, the “Products”).

Eligible Participants

There is no limit to the number of participants in the Program. Participants may be CME members or non-members.

Program Term

Start date is November 14, 2016. End date is ~~June 30, 2017~~ December 31, 2017.

Incentives

Fee Waivers. All Program participants will receive fee waivers on all Globex® trades in the Products. The fee waivers apply to any expiry and to both the option and associated futures hedge resulting from the trade.
