New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to modify the Natural Gas Options Liquidity Provider Program ("Program"). The modifications to the Program will become effective on July 1, 2017.

Exhibit 1 sets forth the terms of the Program. Modifications appear below, with additions <u>underlined</u> and deletions overstruck.

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Prevention of Market Disruption, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program and modifications do not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The products included in this Program are listed for trading in the open and competitive market. Participants in the Program will be selected by NYMEX staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with NYMEX in which each participant will expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

NYMEX certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program or the proposed modifications.

EXHIBIT 1

Natural Gas Options Liquidity Provider Program

Program Purpose

The purpose of the Program is to incentivize higher levels of volume contribution in NYMEX energy options products, specifically in natural gas options products across NYMEX's trading and clearing venues. Higher levels of volume and liquidity in the products listed below benefits all participants in the marketplace.

Product Scope

All NYMEX Natural Gas options products that are traded on the Globex Platform, the NYMEX trading floor, or submitted for clearing through CME ClearPort ("Products").

Eligible Participants

NYMEX may designate up to ten (10) participants in the Program. Participants may be NYMEX members or non-members. In order to be considered for the Program, NYMEX will take into account (i) historical volume and experience trading the Products and similar options contracts, and (ii) the participant's ability to maintain minimum volume requirements for the duration of the Program. NYMEX may, in its sole discretion, add or subtract from the aforementioned factors as it deems necessary.

Program Term

Start date is October 1, 2014. End date is June 30, 2017 June 30, 2018.

Hours

Incentives

Upon satisfying the eligibility requirements and obligations under the Program, participants may be eligible to receive predetermined incentives.

Monitoring and Termination of Status

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke Program participant status if it concludes from review that a Program participant has failed to meet its obligations or no longer meets the eligibility requirements of the Program.
