**Re: New MSCI EAFE Index Contracts Designated Market Maker Program
Submission Pursuant to Section 5c(c)(1) of the Act and Regulation 40.6**

Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC”) Regulation 40.6(a), ICE Futures U.S., Inc. (“IFUS” or “Exchange”) hereby submits by written certification, notice that the Exchange is launching the MSCI EAFE Index Contracts Designated Market Maker Program (“Program”). The terms and conditions of the new Program, which the Exchange believes will increase liquidity and volume in the MSCI EAFE Index contracts, are set forth in Exhibit A.

The Exchange certifies that the new Program, which will become effective on July 1, 2019, complies with the requirements of the Commodity Exchange Act and the rules and regulations promulgated thereunder. In particular, the Program complies with Core Principle 4 (Monitoring of Trading), Core Principle 9 (Execution of Transactions) and Core Principle 12 (Protection of Market Participants). The Program does not impact order execution priority or otherwise give participants any execution preference or advantage. In addition, the Exchange’s Market Regulation Department actively monitors for trading abuses using electronic exception reports and will take appropriate action against any participants engaging in market abuses.

The Exchange is not aware of any opposing views with regard to the Program and further certifies that, concurrent with this filing, a copy of this submission was posted on the Exchange’s website at (<https://www.theice.com/futures-us/regulation#rule-filings>).

EXHIBIT A

ICE Futures MSCI EAFE Index Contracts Designated Market Maker Program

Program Purpose

The purpose of the Program is to incentivize participants to increase central limit order book liquidity in the Exchange's MSCI EAFE Index futures and related contracts; this enhanced liquidity will benefit all participants in the marketplace.

Product Scope

Futures contracts on the MSCI EAFE Index - contract symbol MFS (the "EAFE Contract"); and the MSCI World, ACWI, Canada, USA, North America, Pacific, Euro, Europe and Pan Euro Indexes (collectively the "EAFE-Associated Contracts").

Eligible Participants

IFUS may designate any number of participants in the Program. In order to be considered for selection into the Program, potential participants must have maintained a sufficient monthly average volume in one or more of the Program contracts over the past six months at the time of application. Notwithstanding the foregoing the Exchange may add or subtract from the aforementioned criteria as it deems necessary.

Program Term

The initial term of the program term shall begin on July 1, 2019 and end on December 31, 2019.
