Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6(a), ICE Futures U.S., Inc. ("IFUS" or "Exchange") self certifies amendments to the fees for block and EFRP trades of Russell Complex Futures and Options Contracts, which are being increased from \$0.30 and \$0.64 per side to \$5.00 per side effective on July 12, 2017, as set forth in Exhibit A. All other Exchange and clearing fees for Russell Complex Futures and Options, which can be found at https://www.theice.com/fees, remain unchanged.

The Exchange is not aware of any opposing views with respect to the amendment and certifies that the amendments comply with the requirements of the Commodity Exchange Act and the rules and regulations promulgated thereunder.
