Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the “Act”), and Section 40.6(d) of the Commission’s regulations thereunder, NASDAQ Futures, Inc. (“NFX” or “Exchange”) submits this notification of the following rule amendment made effective during the preceding week.

On June 20, 2017, the Exchange issued Futures Trader Alert #2017 – 13<sup>1</sup> announcing the initial listing of trading months in 7 NFX Minnesota MISO and 20 Mini Off-Peak, Day-Ahead Futures Contracts for trade date June 30, 2017. The rule amendments related to the new contracts went into effect on June 29<sup>th</sup>. The trading months for the new contracts, which were previously certified pursuant to Commission Rule 40.2 on June 15, 2017,<sup>2</sup> were set forth in the Futures Trader Alert as follows:


