Dear Mr. Kirkpatrick:

New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to modify the International Coal API2 Market Maker Program ("Program"). The proposed modifications to the Program will become effective on August 1, 2018.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions underlined and deletions ~~overstruck~~.

The Exchange reviewed the designated contract market Core Principles as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, NYMEX has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The products included in this Program are listed for trading in the open and competitive market. Participants in the Program are selected by Exchange staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

The Exchange certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

EXHIBIT 1

International Coal API2 Market Maker Program

Program Purpose

The purpose of this Program is to build liquidity in the international coal products listed below. The resulting increase in central limit order book liquidity benefits all participant segments in the market.

Product Scope

Coal (API2) CIF ARA (ARGUS-McCloskey) Futures ("MTF") and Coal (API4) FOB Richards Bay (ARGUS-McCloskey) Futures ("MFF") that are traded on the CME Globex Platform (the "Products").

Eligible Participants

~~The Exchange may designate up to three (3) There is no limit to the number of participants in the Program. Participants may be NYMEX members or non-members. Potential participants are required to submit an application/bid sheet to the Exchange as part of a competitive application process which is used to determine eligibility. In determining whether a prospective participant is selected to participate in the Program, the Exchange may take into account a variety of factors including the strength of the quoting obligations the prospective participant is willing to commit to provide, the ability of the prospective participant to maintain such obligations, and the prospective participant's historical activity in the Product. Notwithstanding the foregoing, the Exchange may add or subtract from the aforementioned factors as it deems necessary.~~

Program Term

Start date is November 1, 2017. End date is January 31, 2019.

Hours

Designated hours between 8:00AM - 6:00PM GMT UK Time.

Obligations

In order to be eligible to receive the Program incentives, participants must quote two-sided markets in the Products at predetermined average bid/ask spreads and minimum quote sizes.

Incentives

Upon satisfying all Program obligations, as determined by the Exchange, each participant will be eligible to receive predetermined incentives.

Monitoring and Termination of Status

The Exchange shall monitor participants' activity in the Products and retains the right to revoke Program participant status if it concludes from review that a Program participant no longer meets the eligibility criteria or obligations of the Program.
