Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchanges submit this weekly notification of the following rule amendments made effective during the week of July 11, 2022.

On Wednesday, July 13, 2022, New York Mercantile Exchange, Inc. (“NYMEX”) and COMEX (collectively, the “Exchanges”) amended the Trading at Settlement (“TAS”) and Trading at Marker (“TAM”) metal table (the “Table”) located in Chapter 5 (“Trading Qualifications and Practices”) of the NYMEX/COMEX Rulebook to include the specific TAS contract month spreads that have previously been deemed spread eligible during each calendar month. The amendments will align the Tables with similar tables in other CME Group asset classes. The amendments will also provide more clarity and transparency to the product offerings as these spread eligible contract months are already operationally TAS eligible as previously certified with the CFTC. Exhibit A provides the Table inclusive of NYMEX and COMEX metals TAS eligible spread transactions.
