Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to modify the CNH Cash-Settled Futures Market Maker Program ("Program"). The modifications to the Program will become effective on August 16, 2019.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA" or "Act"). During the review, CME staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA and the Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' obligations to ensure proper distribution of earned incentives. The incentives in the Program do not impact the Exchange's order execution. Participants in the Program will be selected by Exchange staff using criteria as further stated in Exhibit 1. Chapter 4 of the CME rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with the Exchange in which each participant will expressly agree to comply with and be subject to applicable regulations and CME rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

CME certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

## **EXHIBIT 1**

## **CNH Cash-Settled Futures Market Maker Program**

### **Program Purpose**

The purpose of this Program is to incent market makers to enhance liquidity in the product listed below. The resulting increase in central limit order book liquidity on the CME Globex® Platform ("Globex") benefits all participant segments in the market.

### **Product Scope**

Cash-Settled Standard-Size USD/Offshore RMB Futures ("CNH") that are traded on Globex (the "Product").

### **Eligible Participants**

CME may designate up to fourteen (14) participants in the Program with a maximum of seven (7) participants in each Program module. Participants may be CME members or non-members. Potential participants are required to submit an application/bid sheet to the Exchange as part of a competitive application process which is used to determine eligibility. In determining whether a prospective participant is selected to participate in the Program, Exchange staff may take a variety of factors into consideration including the strength of the quoting obligations the prospective participant is willing to commit to provide, the ability of the prospective participant to maintain such obligations, and historical volume trading the Products and similar contracts. The Exchange may, from time to time, add or subtract from the aforementioned requirements as it deems necessary.

## **Program Term**

Start date is August 1, 2018. End date is July 31, 2020.

#### Hours

Designated hours from 9AM to 1AM Singapore Time ("Hours").

## **Obligations**

In order to be eligible to receive the Program incentives, participants must meet certain volume thresholds and/or quote two-sided markets in the Product, at predetermined bid/ask spreads and minimum quote sizes.

## **Incentives**

Upon meeting all Program obligations, as determined by the Exchange, participants may be eligible to receive predetermined incentives.

# **Monitoring and Termination of Status**

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant no longer meets the eligibility requirements or fails to meet the obligations of the Program.
