Dear Mr. Kirkpatrick:

Chicago Mercantile Exchange Inc. (“CME”) and The Board of Trade of the City of Chicago, Inc. (“CBOT”) (collectively, the “Exchanges”) hereby certify to the Commodity Futures Trading Commission (“CFTC” or “Commission”) the elimination of: (1) the CME Globex trading halt for certain CME and CBOT equity futures and options contracts as provided in Exhibit A attached and (2) the open outcry trading venue for the CME Options on One-Month SOFR Futures and Options on Three-Month SOFR Futures contracts (collectively, the “Rule Amendments”) effective on Sunday, June 27, 2021 for trade date Monday, June 28, 2021.

CME Submission No. 21-244R advises that CME shall withdraw the action described in (2) below at this time. No other changes have been made to the original CME Submission No. 21-244.

1. Elimination of CME Globex Trading Halt for ALL CME and CBOT Equity Futures and Options Contracts:

CME and CBOT will eliminate the 3:15 p.m. – 3:30 p.m. Central Time (CT) trading halt on CME Globex which currently exists for certain Equity futures and options contracts. The halt was initially implemented to account for transactions conducted via open outcry in the trading pits and is therefore no longer necessary.

2. Elimination of Open Outcry Trading Venue for Options on One-Month and Three-Month SOFR Futures Contracts

As a result of trading activity, CME will eliminate the open outcry trading venue for Options on One-Month SOFR Futures (Rulebook Chapter 461A) and Options on Three-Month SOFR Futures (Rulebook Chapter 460A). These contracts will continue to be listed for trading on the CME Globex electronic trading platform and for submission for clearing via CME ClearPort.

The Exchanges reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” or “Act”) and identified the following Core Principles as being potentially impacted by the Rule Amendments:

- **Compliance with Rules** – All trading hours will continue to be subject to the full range of rules in the CME & CBOT Rulebook Chapters, including all monitoring, surveillance, and enforcement provisions.
- **Execution of Transactions** – The Rule Amendments will not impact the Exchanges’ order execution, which will continue in the same manner as before.
- **Prevention of Market Disruption** – The capacity and responsibility to prevent manipulation, price distortion, and disruptions of the delivery or cash-settlement process through market surveillance, compliance, and enforcement practices and procedures will continue.
- **Availability of General Information** – The Rule Amendments will be made known to the trading community in advance of the effective date via the dissemination of a Special Executive Report (“SER”). The SER will also be posted on the CME website.
- **Daily Publication of Trading** – All trades will be posted in the Daily Bulletin and published on the CME website.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchanges hereby certify that the Rule Amendments comply with the Act, including regulations under the Act.

There were no substantive opposing views to the Rule Amendments.
