Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(a), New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is certifying amendments to the position limits aggregation for certain energy futures and options contracts to incorporate the CFTC position limit regulations and definitions of referenced contracts (the "Rule Amendments") to be concurrently effective with the CFTC regulations on trade date January 4, 2022.

Specifically, the Rule Amendments are incorporated in the Position Limit, Position Accountability and Reportable Level Table and Header Notes located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook (the "Table"). Appendix A provided under separate cover, provides the Table with additions underscored and deletions struck through.

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("Act") and identified that Rule Amendments may have some bearing on the following Core Principles.

- Contracts Not Readily Subject to Manipulation: The Contracts are not readily subject to manipulation due to the deep liquidity and robustness in the underlying physical markets.
- <u>Position Limitations or Accountability</u>: The speculative position limits for the Contracts as demonstrated in this submission are consistent with the Commission's guidance.
- <u>Availability of General Information</u>: The information contained herein will be disseminated to the
 marketplace via Market Surveillance Notice. The Exchange will publish information on the
 Contracts' specifications on its website, together with daily trading volume, open interest, and price
 information.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the Rule Amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
