Re: CFTC Regulation 40.6(a) Certification: Submission of Amendment to the Nodal Exchange Participant Agreement

Dear Mr. Kirkpatrick:

Nodal Exchange, LLC ("Nodal Exchange" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying several amendments to the Nodal Exchange Participant Agreement ("Participant Agreement") pursuant to Commission Regulation 40.6(a). The amended Participant Agreement is attached hereto and indicates the specific text in red that is being amended. The Exchange intends to implement the amended Participant Agreement in 10 business days on November 30, 2015.

The amendments to the Participant Agreement consist of deletions to terms that were necessary when Nodal Exchange's clearing house was LCH.Clearnet ("LCH") because certain provisions in the Participant Agreement were only applicable to the Exchange and its Affiliates (as defined in the Participant Agreement). Since October 19, 2015, when Nodal Exchange transitioned its clearing house from LCH to Nodal Clear, such terms being deleted in the Participant Agreement were no longer relevant because Nodal Clear is the Exchange's Affiliate.

Exchange management has assessed the amendments to the Participant Agreement, and its compliance with applicable provisions of the Commodity Exchange Act ("Act"), including the Commissions Regulations and the Core Principles. Nodal Exchange has identified that the amendments may affect Core Principle 7 – Availability of General Information regarding the terms and conditions of the Participant Agreement.


