CONCISE EXPLANATION AND ANALYSIS OF THE OPERATION, PURPOSE, AND EFFECT OF THE PROPOSED RULE AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION’S REGULATIONS THEREUNDER

Eurex Clearing is proposing amendments to the Clearing Conditions to reflect Eurex Deutschland and Eurex Clearing’s plan to launch extended trading and clearing hours for selected equity index futures listed on Eurex Deutschland into the Asian time zone. For avoidance of doubt, this trading and clearing hours extension applies only to certain products listed on Eurex Deutschland, which Eurex Clearing clears outside of its derivatives clearing organization (“DCO”) license. Eurex Clearing Circular 097/18, which is appended as Attachment A, provides further information on the product scope, system availability, and risk functionalities for this change.

Eurex Clearing has identified the following DCO Core Principle as potentially being relevant to the above amendments:

1. DCO Core Principle C (Participant and Product Eligibility): The proposed amendments will comply with DCO Core Principle C because the amendments propose extended trading and clearing hours for certain products listed on Eurex Deutschland, which are cleared outside of Eurex Clearing’s DCO license, and Eurex Clearing will continue to clear all products that fall under Eurex Clearing’s DCO license in compliance with this Core Principle.
