Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c) of the Commodity Exchange Act, as amended (“Act”), and Section 40.6 of the Commission’s regulations thereunder, Small Exchange, Inc. d/b/a crypto.com | Derivatives North America (the “Exchange”) submits this self-certification as written notice that the Exchange amending its Fee Schedule, as set forth on the attached Exhibit A (marked and clean versions, respectively), which is attached hereto and incorporated herein by reference (“Rule Change”). The Rule Change is effective January 3, 2023.

The Exchange reviewed the designated contract market (“DCM”) core principles (“Core Principles”) as set forth in the CEA. During the review, Exchange staff identified the following Core Principles as potentially being impacted:

- Core Principle 7, Availability of General Information: As required by this Core Principle, the Exchange will publish the modified Fee Schedule on the Exchange’s website (www.thesmallexchange.com) to ensure that market participants have been advised of the revised fees. The Exchange will also issue a Regulatory Notice to the marketplace regarding the revised fees.
- Core Principle 21, Financial Resources: The proposed fee changes will not impact the Exchange’s ability to discharge its financial, operational, or managerial responsibilities as a DCM.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6, the Exchange certifies that the amendments comply with the Act, including regulations under the Act. The Exchange is not aware of any opposing views. The Exchange also certifies that this submission has been posted on the Exchange's website at www.thesimalexchange.com.
