Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and Section 40.6 of the regulations promulgated by the Commodity Futures Trading Commission ("Commission") under the Act, NASDAQ Futures, Inc. ("Exchange") submits this self-certification to specify the days and hours the Exchange will be closed for business in 2015. This filing will be effective on December 9, 2014.
