Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following rule amendments effective during the week of December 6, 2021.

On December 6, 2021, the Exchange issued MRAN RA2118-5 (“MRAN”) to implement administrative amendments to reflect the delisting of four (4) Commodity Index Forward Swap contracts (the “Contracts”) on the List of Products Subject to Large Trader Reporting of Physical Commodity Swaps under CFTC Part 20 Regulations Physical Commodity Swaps under CFTC Part 20 Regulations contained therein. The Contracts were also delisted on December 6, 2021. No other changes were made to the original MRAN.

Amendments to the MRAN are provided in Exhibit A below with additions underscored and deletions ~~struck through~~.
