New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") that it plans to modify the Natural Gas Financial Futures Spread Program ("Program"). The modifications to the Program will become effective on January 1, 2016.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

The Exchange reviewed the designated contract market Core Principles as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Prevention of Market Disruption, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program will not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, NYMEX has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The products included in this Program are listed for trading in the open and competitive market. Participants in the Program will be selected by Exchange staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

The Exchange certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

## **EXHIBIT 1**

# **Natural Gas Financial Futures Spread Program**

## **Program Purpose**

The purpose of this Program is to build liquidity in the NYMEX products listed below that are traded on the CME Globex Platform. The resulting increase in central limit order book liquidity for these products on the CME Globex Platform benefits all participant segments in the market.

### **Product Scope**

Henry Hub Natural Gas Last Day Financial Futures ("NN") that are traded on the CME Globex Platform ("Products").

## **Eligible Participants**

The Exchange may designate up to ten (10) participants in the Program. There is no limit to the number of participants that may participate in the Program. Participants may be NYMEX members or non-members. Prospective participants are required to submit an application/bid sheet to the Exchange as part of a competitive application process which is used to determine eligibility. In determining whether or not a prospective participant is selected to participate in the Program, the Exchange may take into account a variety of factors including (1) the prospective participant's historical volume in the Products, (2) the prospective participant's experience trading NYMEX products and similar futures contracts, and (3) the prospective participant's ability to meet the pre-determined quoting obligations of the Program. Notwithstanding the foregoing, the Exchange may add or subtract from the above factors as it deems necessary.

### **Program Term**

Start date is April 1, 2015. End date is December 31, 2015 December 31, 2016.

#### Hours

Designated hours during RTH ("Hours")

## **Incentives**

Upon meeting all requirements, as determined by the Exchange, participants may be eligible for predetermined incentives.

## **Monitoring and Termination of Status**

The Exchange shall monitor participants' activity in the Products and retains the right to revoke Program participant status if it concludes from review that a Program participant no longer meets the eligibility requirements of the Program.
