Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to implement the SOFR Options Pit Liquidity Provider Program ("Program"). The proposed Program will become effective on January 6, 2020.

Exhibit 1 sets forth the terms of this Program.

CME reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, CME staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program will not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA and the Exchange's market regulation staff will monitor trading under the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' obligations to ensure proper distribution of earned incentives. The incentives in the Program do not impact the Exchange's order execution. Participants in the Program will be selected by Exchange staff using criteria as further stated in Exhibit 1. Chapter 4 of the CME rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with the Exchange in which each participant will expressly agree to comply with and be subject to, applicable regulations and CME rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

CME certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

## **EXHIBIT 1**

# **SOFR Options Pit Liquidity Provider Program**

#### **Program Purpose**

The purpose of this Program is to encourage participants to support the launch and development of the products listed below. The resulting increase in liquidity benefits all participant segments of the market.

#### **Product Scope**

All Options on Three-Month SOFR Futures traded on the CME Globex Platform, traded via Open Outcry, or cleared through CME ClearPort ("Products").

#### **Eligible Participants**

There is no limit to the number of participants that may participate in the Program. Participants must be CME members that meet at least one (1) of the two (2) criteria below:

- (1) Firm employee trading a firm account through sequential trading cards, or
- (2) Individual member trading from sequential trading cards.

#### **Program Term**

Start date is January 6, 2020. End date June 30, 2020.

#### **Incentives**

<u>Fee Waivers</u>: All participants will receive fee waivers in the Products traded on the CME Globex Platform, traded via Open Outcry, or cleared through CME ClearPort.

<u>Fee Credits</u>: All participants will receive a \$1.00 fee credit for each transaction in the Products on the CME Globex Platform, Open Outcry, or CME ClearPort. Fee credits will be capped at \$30,000 per month, per participant.

### **Monitoring and Termination of Status**

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke Program participant status if they conclude from review that a Program participant no longer meets the eligibility requirements of the Program.
