Dear Mr. Kirkpatrick:

Chicago Mercantile Exchange Inc., in its capacities as both a derivatives clearing organization (“DCO”) and a designated contract market (“DCM”) (“CME”), and The Board of Trade of the City of Chicago, Inc. (“CBOT”), in its capacity of a DCM, (collectively, the “Exchanges”) are certifying to the Commission:

- (1) amendments to the listing schedule of certain commodity index futures and swap contracts as described below in Tables 1., 2., and 3. below (collectively, the “Contracts”) effective on trade date Monday, June 17, 2024.
- (2) *effective immediately*, the contract months noted in Table 3. below will be delisted for trading on the CME Globex electronic trading platform (“CME Globex”) and for submission for clearing via CME ClearPort. There is no open interest in the delisted contract months.
- (3) amendments to CBOT Chapters 29 and 29D to delete references to the listing schedule of these contracts from the product chapters and insert the listing schedule in the related contract specifications to align with other CME and CBOT products effective on trade date Monday, June 17, 2024 (see Exhibit A).
- (4) amendments to the fee schedule for the Contracts effective on trade date Monday, June 17, 2024 (see Exhibit B) (collectively, the “Rule Amendments”).

The Exchanges are implementing the Rule Amendments to more appropriately align the listing schedule with other CME and CBOT commodity index products.

The Exchanges reviewed the DCO and DCM core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” or “Act”) and identified that the Rule Amendments may have some bearing on the following Core Principles:

DCO Core Principles:

Public Information: CME shall disseminate a Special Executive Report (“SER”) regarding the Rule Amendments. The SER will also be posted on the CME Group website.

DCM Core Principles:

Emergency Authority: As there is no open interest in any of the contract months to be delisted, there will be no market disruption related to their delisting.

Availability of General Information: The Exchanges will release a Special Executive Report (“SER”) regarding the Rule Amendments. The SER will also be posted on the CME Group website.

Daily Publication of Trading Information: The Exchanges will continue to publish contract trading volumes, open interest levels, and price information daily on its website and through quote vendors for the Contract.

Compliance with Rules: The Exchanges shall continue its normal practice to establish, monitor, and enforce compliance with the rules of the Contracts.

Execution of Transactions: Following the implementation of the Rule Amendments, the Exchanges will continue to provide a competitive, open, and efficient market and mechanism for executing transactions that protects the price discovery process of trading for the Contracts.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchanges hereby certify that the Rule Amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to the Rule Amendments.
