Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6(d), ICE Futures U.S., Inc. (“Exchange”) submits notification to the Commission that, during the preceding week, the Exchange issued the notice attached as Exhibit A regarding the extension of the last trading day of the May 2024 expiration of certain Exchange Auction Clearing Price futures contracts due to the postponement of the Joint Auction Summary report which coincides with the last trading day for such contracts. The extension of the last trading day was taken in accordance with the contracts’ terms and conditions, which provide that “[t]rading may be extended until 3:00 p.m. of the day that is the Last Trading Day for the eligible CCA futures contract ... if the release of the Report is delayed for any reason.” The amendments were non-substantive in nature and no other amendments were made to the terms and conditions of the contracts.

Notice of Extension of Last Trading Date for California Carbon Allowance Auction Clearing Price Futures

On May 15, 2024, the Exchange became aware via an **announcement** from the California Air Resources Board (CARB) that due to technical difficulties, the May 2024 Joint Auction #39 that was scheduled to take place on May 15, 2024 would be postponed to a later date. Today it was announced that Joint Auction #39 has been **rescheduled** to May 22, 2024. The Joint Auction Summary Results Report, which coincides with the last trading day for the Auction Clearing Price futures, is scheduled to be released on May 30, 2024. Consequently, pursuant to the contract specifications, the Exchange will extend the last trading date of the Auction Clearing Price futures contracts listed below to May 30, 2024. For the avoidance of doubt, open positions in the May 2024 contract month of the Auction Clearing Price futures will establish equivalent positions in the underlying June 2024 California Carbon Allowance futures contracts at expiration.
