Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to modify the FX Link Bank Incentive Program ("Program"). The modifications to the Program will become effective on July 1, 2024.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

CME reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, CME staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, Availability of General Information, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. Exchange staff will monitor trading in the Program's products in order to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The Program does not impact the Exchange's order execution. Participants in the Program will be selected by CME staff using criteria as set forth in Exhibit 1. Chapter 4 of the Exchange rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with CME in which each participant will expressly agree to comply with, and be subject to, applicable regulations and Exchange rules. Additionally, the Program is subject to the Exchange's record retention policies, which comply with the CEA.

CME certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

## **EXHIBIT 1**

# **FX Link Bank Incentive Program**

### **Program Purpose**

The purpose of this Program is to incentivize participants to support the development of FX Link and to provide liquidity in FX futures traded via FX Link. More liquid contracts on the central limit order book benefit all participants in the marketplace.

#### **Product Scope**

All FX futures traded via FX Link on the CME Globex® Platform ("Products").

## **Eligible Participants**

The Exchange may designate up to ten (10) participants in the Program. Participants may be CME members or non-members. Participants must be classified as a bank. Potential participants are required to submit an application/bid sheet to the Exchange as part of a competitive selection process which is used to determine eligibility. In determining whether or not a prospective participant is selected to participate in the Program, Exchange staff may take into account a variety of factors including historical volume trading FX products. The Exchange may, from time to time, add or subtract from the aforementioned requirements as it deems necessary.

## **Program Term**

Start date is January 1, 2021. End date is <del>June 30, 2024</del> <u>June 30, 2025</u>.

## **Hours**

N/A

#### **Obligations**

In order to be eligible to receive the incentives, participants must meet predetermined volume thresholds in the Products.

## **Incentives**

Upon meeting all obligations, as determined by the Exchange, participants may be eligible to receive predetermined incentives.

### **Monitoring and Termination of Status**

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant has failed to meet the eligibility requirements or obligations of the Program.
