Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of June 3, 2024.

On June 3, 2024, the Exchange made a change to the Gold (GC), Gold (4GC), and Gold Kilo (GCK) brand lists to reflect corresponding changes at the LBMA.
