Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following rule amendments made effective during the week of September 30, 2024.

On September 18, 2024, the Exchange submitted [24-406](#) regarding harmonization of Clearing and Market Regulation disciplinary process effective on October 3, 2024. Inclusive in that filing was a revision to the definition of “Investigative and Hearing Committees” in Chapter iii (“Definitions”) of the Rulebook. The definition included the term “Floor Conduct Committee” which only applies to the CME Rulebook. The corrected NYMEX/COMEX Chapter iii is included below in Exhibit A in blackline format.
