Re: DCO Notice of Changes to Scheduled Maintenance Periods of a DCM that Impact Trading Hours.

Dear Sir or Madam,

Kalshi Klear LLC (“Kalshi”) hereby notifies the Commodity Futures Trading Commission (“CFTC”) that it is self-certifying this filing pursuant to Commodity Exchange Act (“CEA”) Section 5c and CFTC Regulation 40.6(a), effective October 30, 2024.

Rule 1.1 of Kalshi’s Rulebook defines Trading Hours as “The hours during which Orders may be entered according to the rules of a SEF or DCM that clears through the Company, and as may be revised from time to time by such SEF or DCM.” Kalshi’s Rule 5.12 provides that “Trading shall be available at all times outside of any maintenance windows, which may be announced from time to time.” Kalshi announces maintenance windows that may impact the hours that trading is available on its website, at <https://help.kalshi.com/faq/what-are-trading-hours>. This filing is to notify that there is no scheduled maintenance window from 8:00 AM ET on Monday, November 3, 2024 to 3:00 AM ET on Sunday, November 10, 2024. There will be scheduled maintenance from 3:00 AM ET to 8:00 AM ET on Sunday, November 10, 2024, and from Monday, November 11, 2024, there will be daily scheduled maintenance from 3:00 AM ET to 8:00 AM ET. As a result of these maintenance windows, trading will be available on Kalshi as follows:

- On a daily basis, unless otherwise announced, from 8:00 AM ET to 3:00 AM ET.
- From 8:00 AM ET on Monday, November 3, 2024 to 3:00 AM ET on Sunday, November 10, 2024.

Compliance with Core Principles

Kalshi has concluded that this filing is not inconsistent with the CEA and the CFTC’s regulations. In particular, the following core principles may be pertinent:

Core Principle L – Public Information: Core Principle L requires that a DCO make available information concerning its rules and operations to the public and its market participants. This filing relates to public information regarding the hours that Kalshi operates.

No opposing views to the contrary have been expressed.

Kalshi accordingly certifies that the Program complies with the requirements of the Commodity Exchange Act and the rules and regulations promulgated thereunder, and certifies that, concurrent with this filing, a copy of this submission (except for the confidential appendix) was posted on the Kalshi website and may be accessed at: <https://kalshi.com/regulatory/notices>.
