Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of December 9, 2024.

On December 11, 2024, the Exchange implemented administrative amendments to the COMEX Position Limit, Position Accountability and Reportable Level Table (the “Table”) to correct administrative errors in the Type and Settlement columns for North European Hot-Rolled Coil Steel (Argus) Average Price Option (Commodity Code: EHO). Exhibit B of COMEX Submission No. 22-090 dated April 11, 2022 shows that the Type column was erroneously populated with Futures and the Settlement Column was erroneously populated with Financially Settled Futures for the contract. The Type column will be populated with Eu. Option and the Settlement column will be populated with Financially Settled Option for the contract. These amendments to the Table are provided under separate cover in Exhibit A in blackline format.
