By way of background, the Exchange previously advised that the Contracts would be listed only through December 2025 (see NYMEX Submission 23-222 dated May 18, 2023).

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("Act" or "CEA") and identified that the amendments to the Contracts may have some bearing on the following Core Principles:

- Availability of General Information: NYMEX will issue a Special Executive Report ("SER") to the marketplace regarding the Rule Amendments. The SER will also be posted on the CME Group website.
- <u>Publication of Trading Information</u>: NYMEX will continue to comply with this Core Principle by making public daily information on settlement prices, volume, open interest, and opening and

closing ranges for the Contracts. This will be accomplished by publishing this information on a daily basis on the Exchange's website.

- <u>Compliance with Rules</u>: The Exchange shall continue its normal practice to establish, monitor, and enforce compliance with the rules of the Contracts, including the expansion of the listing schedule of the Contracts.
- **Execution of Transactions**: The Exchange will continue its current practice of providing a competitive, open, and efficient market mechanism for executing transactions in the Contracts, including the expansion of the listing schedule of the Contracts.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the Rule Amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
