RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for the Week of December 27, 2016 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added strike levels on a discretionary basis in its Daily US Tech 100 Binary contracts on December 27, 2016 and returned to its regular listing schedule for these contracts on December 28, 2016. Nadex also listed additional strike levels on a discretionary basis in its Daily US Tech 100 Binary contracts on December 30, 2016. Nadex plans to return to its regular schedule for these contracts on January 3, 2017. The specific added discretionary strike levels are attached in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
