Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions effective during the week of December 27, 2021.

On December 1, 2021, the Exchange reviewed and approved applications for the declaration of regularity for the delivery and storage of Spot Call Butter, Spot Call Nonfat Dry Milk, and Spot Call Dry Whey Warehouses. A number of firms did not renew their regularity status, which expired on December 31, 2021. The marketplace was alerted of the expiries via MRK #12-01-21C, which is attached hereto as Exhibit A.

In accordance with the changes above, the Exchange updated the CME Rulebook Chapter 12 “Service Providers” Chart (“Chart”) for “Spot Call Market”. The Chart is attached under separate cover, in blackline format, as Exhibit B.
