RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for the Week of January 9, 2017 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added strike levels on a discretionary basis in its Intraday 1pm Expiration Gold and Daily Natural Gas Binary contracts on January 9, 2017 and returned to its regular listing schedule for the Gold contracts on January10, 2017. Nadex also listed additional strike levels on a discretionary basis in its Daily Natural Gas and Copper Binary contracts on January 10, 2017, and returned to its regular listing schedule for these contracts on January 11, 2017. Finally, Nadex added discretionary strike levels due to volatility in the underlying market on January 12, 2017 in its Daily US Tech 100, Wall Street 30, US SmallCap 2000, Gold, and Copper Binary contracts. Nadex returned to its regular schedule for these contracts on January 13, 2017. The specific added discretionary strike levels are attached in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
