Dear Sir or Madam,

Pursuant to Section 5c(c) of the Commodity Exchange Act and Section 40.2(a) of the regulations of the Commodity Futures Trading Commission, KalshiEX LLC (Kalshi) hereby notifies the Commission that it is self-certifying the “Will the Federal government shut down for <above> <days>?” contract (Contract). The Exchange intends to list it in conjunction with government shutdowns caused by lapses in budget appropriations. The Contract’s terms and conditions (Appendix A) includes the following strike conditions:

- <day_1> (the start date of the target period)
- <day_2> (the end date of the target period)
- <days> (the number of days the Federal Government is shutdown)
- <above>

CONCISE EXPLANATION AND ANALYSIS OF THE PRODUCT AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Pursuant to Commission Rule 40.2(a)(3)(v), the following is a concise explanation and analysis of the product and its compliance with the Act, including the relevant Core Principles, and the Commission's regulations thereunder.

I. Introduction

The “Will the Federal government shut down for <above> <days>?” Contract is a contract relating to government shutdowns. If Congress fails to appropriate money for a given period, the federal government ceases non-essential government activity until such time as the money is appropriated. After careful analysis, Kalshi (hereafter referred to as “Exchange”) has determined that the Contract complies with its vetting framework.

A government shutdown would affect hundreds of thousands of American workers both in the Federal government and outside of the Federal government, their families and the communities those employees help through their work. Even workers deemed essential may continue to work, but will work without pay. In the last government shutdown, for example, roughly 800,000 government employees either did not work or worked without pay¹.

Further information about the Contract, including an analysis of its risk mitigation and price basing utility, as well as additional considerations related to the Contract, is included in Confidential Appendices B, C, and D.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.2(a), the Exchange hereby certifies that the listing of the Contract complies with the Act and Commission regulations under the Act.

General Contract Terms and Conditions: The Contract operates similar to other binary contracts that the Exchange lists for trading. The minimum price fluctuation is \$0.01 (one cent). Price bands will apply so that Contracts may only be listed at values of at least \$0.01 and at most \$0.99. Further, the Contract is sized with a one-dollar notional value and has a minimum price fluctuation of \$0.01 to enable Members to match the size of the contracts purchased to their economic risks. The Exchange has further imposed position limits (defined as maximum loss exposure) of \$25,000 USD on the Contract. As outlined in Rule 5.12 of the Rulebook, trading shall be available at all times outside of any maintenance windows, which will be announced in advance by the Exchange. Members will be charged fees in accordance with Rule 3.6 of the Rulebook. Fees are charged in such amounts as may be revised from time to time to be reflected on the Exchange's Website. Additionally, as outlined in Rule 7.2 of the Rulebook, if any event or any circumstance which may have a material impact on the reliability or transparency of a Contract's Source Agency or the Underlying related to the Contract arises, Kalshi retains the authority to designate a new Source Agency and Underlying for that Contract and to change any associated Contract specifications after the first day of trading. That new Source Agency and Underlying would be objective and verifiable. Kalshi would announce any such decision on its website. All instructions on how to access the Underlying are non-binding and are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time. Furthermore, the Contract's payout structure is characterized by the payment of an absolute amount to the holder of one side of the option and no payment to the counterparty. During the time that trading on the Contract is open, Members are able to adjust their positions and trade freely. After trading on the Contract has closed, the Expiration Value and Market Outcome are determined. The market is then settled by the Exchange, and the long position holders and short position holders are paid according to the Market Outcome. In this case, "long position holders" refers to Members who purchased the "Yes" side of the Contract and "short position holders" refers to Members who purchased the "No" side of the Contract. If the Market Outcome is "Yes," meaning that the government is at least partially shut down for more than <count> days, then the long position holders are paid an absolute amount proportional to the size of their position and the short position holders receive no payment. If the Market Outcome is "No," then the short position holders are paid an absolute amount proportional to the size of their position and the long position holders receive no payment. Specification of the circumstances that would trigger a Market Outcome of "Yes" are included below in the section titled "Payout Criterion" in Appendix A.

APPENDIX A – CONTRACT TERMS AND CONDITIONS

TERMS OF CONTRACTS TRADED ON KALSHI

Official Product Name: Will the Federal government shut down for <above> <days>?

Rulebook: SHUTLENGTH

SHUTLENGTH

Scope: These rules shall apply to this contract.

Underlying: The Underlying for this Contract is notices on the website of the U.S. Office of Personnel Management that indicate the federal government is at least partially shut down between <date_1> and <date_2>. Revisions to the Underlying made after Expiration will not be accounted for in determining the Expiration Value.

Instructions: The current status of government opening is available at: <https://www.opm.gov/policy-data-oversight/snow-dismissal-procedures/current-status/> . In the case of a shutdown, notices may also be available elsewhere on the site of the U.S. Office of Personnel Management. Information about the definition of a shutdown per the OPM is available at this link: <https://www.opm.gov/policy-data-oversight/pay-leave/furlough-guidance/#url=Shutdown-Furlough> . Further information is available here: <https://www.whitehouse.gov/omb/information-for-agencies/agency-contingency-plans/>. Specific information about the FY 2022 shutdown possibilities are available at the OPM at this link: <https://www.opm.gov/policy-data-oversight/pay-leave/furlough-guidance/special-instructions.pdf>. These instructions on how to access the Underlying are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time.

Source Agency: The Source Agency is the Office of Personnel Management.

Type: The type of Contract is an Event Contract.

Issuance: Contract iterations will be listed on an as-needed basis at the discretion of the Exchange and corresponding to the risk management needs of Members.

<date_1>: <date> refers to a calendar <date> specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different statistical periods of <date_1>.

<date_2>: <date> refers to a calendar <date> specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different statistical periods of <date_2>.

<days>: <days> refers to a number of days specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different statistical periods of <days>.

Payout Criterion: The Payout Criterion for the Contract encompasses the Expiration Values that include a notice that the U.S. federal government is at least partially shut down for <above>

<days> due to a lapse in appropriations. Such notices will be checked (and thus a date counted) at 10:00 AM ET. Notices of a lapse in appropriations resulting in emergency furloughs or impacted government operations are encompassed in the Payout Criterion. Notices of office closures due to holidays or inclement weather are not encompassed in the Payout Criterion.

An example from the 2018-2019 shutdown is included below.²

Should no data be available at the Source Agency on the Expiration Time at the Expiration Date, then the Contract would resolve to No.

Minimum Tick: The Minimum Tick size for the referred Contract shall be \$0.01.

Position Limit: The Position Limit for the \$1 referred Contract shall be \$25,000 per Member.

Last Trading Date: The Last Trading Date of the Contract will be the same day as the Expiration Date. The Last Trading Time will be the same as the Expiration time.

Settlement Date: The Settlement Date of the Contract shall be the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The Expiration Date of the Contract shall be the sooner of the first 10:00 AM ET following an event encompassed by the Payout Criterion, the date of the first 10:00 AM ET following a shutdown that the government is operating normally, or one day after <date_2>.

Expiration time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(c) of the Rulebook. Additionally, as outlined in Rule 7.2 of the Rulebook, if any event or any circumstance which may have a material impact on the reliability or transparency of a Contract's Source Agency or the Underlying related to the Contract arises, Kalshi retains the authority to designate a new Source Agency and Underlying for that Contract and to change any associated Contract specifications after the first day of trading.
