Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of January 12, 2015.

On Friday, January 16, 2015, the Exchange approved the renewal of Slaughter Plants for Live Cattle for 2015-2016. The approval is effective from February 1, 2015 until January 31, 2016. There was one name change during the renewal process to change PM Windom, Division of PM Beef Holdings, LLC to PM Beef Holdings, LLC. A notice to the marketplace, MKR#12-31-14, is attached hereto as Exhibit A. The updated table of Approved Slaughter Plants for Live Cattle for 2015-2016 is attached hereto as Exhibit B, with additions underscoring and deletions ~~overstruck~~.
