In NYMEX Submission 21-365, the Exchange certified the initial listing of Japanese Power (Day-Ahead) Tokyo Base-Load Average Price Option contract (Rulebook Chapter: 795; Commodity Code: JTO) (the "Contract") for trading on the CME Globex electronic trading platform ("CME Globex") and for submission for clearing via CME ClearPort effective on Sunday, January 23, 2022 for trade date Monday, January 24, 2022.
