RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for the Week of January 25, 2016 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily US SmallCap 2000, Wall Street 30, and US Tech 100 Binary contracts on January 26, 2016. Additionally, Nadex added discretionary strike levels in its Daily US Tech 100 Binary contracts on January 27, 2016. Finally, Nadex added additional strike levels on a discretionary basis in its Daily US SmallCap 2000, Wall Street 30, US 500, US Tech 100, and Bitcoin Binary contracts on January 29, 2016. Nadex also narrowed the strike interval width in its Daily Bitcoin contracts from 1.5 to 1 on January 29, 2016. Nadex plans to return to its regular listing for all contracts on February 1, 2016.

Additional strikes are attached hereto in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive

opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
