New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the temporary suspension from listing of previously-listed contract months of three (3) European Union Allowances futures and option contracts (the "Contracts") as noted in the table below, effective immediately and until April 30, 2019. There is no open interest in the Contracts.

The Contracts make use of a UK registered entity for physical delivery of the underlying commodity. In light of the Brexit negotiations and related uncertainty in connection with memberships of the UK in the European Union Emissions Trading System ("EU ETS"), the Exchange is taking this action in an effort to maintain an orderly market.

The Exchange reviewed the designated contracts market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA" or "Act") and identified that the suspension may have some bearing on the following Core Principles:

- **Emergency Authority:** There is no open interest in the Contract, and therefore there will be no market disruption related to the temporary suspension.
- Availability of General Information: The Exchange will make publicly available the details of the
  temporary suspension of the Contracts by publishing a Special Executive Report ("SER") to the
  marketplace. The SER will be available on CME Group's website. Following the period of
  suspension, the Exchange will continue to publish on its website information regarding the

Contract's specifications, terms, and conditions, as well as daily trading volume, open interest, and price information.

• **Prevention of Market Disruption:** Following the period of suspension, trading in the Contracts will continue to be subject to the rules of the Exchange, which include prohibitions on manipulation, price distortion, and disruption to the cash settlement process.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.6(a), the Exchange hereby certifies that suspension of trading of the Contracts complies with the Act, including regulations under the Act. There were no substantive opposing views to the proposal.
