Pursuant to Commission Rule 40.6(d), the Exchange submits this notification of the following rule amendment made effective during the preceding week.

On February 1, 2016, the Exchange issued Futures Trader Alert #2016 – 2<sup>1</sup>, announcing the initial listing of trading months in seven new financially settled crude oil and refined products futures contracts within the currently established cycle of trading months, effective February 1, 2016 for trade date February 2, 2016 and beginning with the February 2016 contract month. The trading months for the new contracts, which were previously certified pursuant to Commission Rule 40.2 on January 14, 2016<sup>[2]</sup>, are as follows:
