Dear Mr. Kirkpatrick:

Pursuant to Commission Rule 40.6(d), the Exchange submits this notification of the following rule amendment made effective during the preceding week.

On February 8, 2016, the Exchange issued Futures Trader Alert #2016 – 3^{-1} announcing the initial listing of trading months in fifteen new financially settled real-time and day-ahead mini power futures contracts within the currently established cycle of trading months, effective February 8, 2016 for trade date February 9, 2016. The trading months for the new contracts, which were previously certified pursuant to Commission Rule 40.2 on January 22, 2016 ^[2], were set forth in the Futures Trader Alert as follows:
