Dear Mr. Kirkpatrick:

Chicago Mercantile Exchange Inc. (“CME” or “Exchange”) hereby notifies the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying that it will list the June 2018 contract month of Live Cattle Futures and Options contracts listed in the table below (the “Contracts”) effective on Sunday, March 5, 2017 for trade date Monday, March 6, 2017.

Previously, the Exchange temporarily delayed the listing schedule of the Contracts by not listing the October 2017 contract month and subsequent contract months of the Contracts (see CME Submission No. 16-141 dated April 14, 2016). Effective Sunday, August 21, 2016, the Exchange listed the October 2017 contract month of the Contracts (see CME Submission No. 16-304 dated August 5, 2016). Effective Sunday, October 2, 2016, the Exchange listed the December 2017 contract month of the Contracts (see CME Submission No. 16-376 dated September 16, 2016). Effective Sunday, November 6, 2016, the Exchange listed the February 2018 contract month of the Contracts (see CME Submission No. 16-425 dated October 19, 2016). Effective Monday, January 2, 2017, the Exchange listed the April 2018 contract month of the Contracts (see CME Submission No. 16-553 dated December 14, 2016).

CME has received market feedback advising that the June 2018 contract month of the Contracts should be listed as soon as possible in order to facilitate hedging needs. The Exchange will continue to delay listing subsequent contract months of the Contracts at this time.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (the “Act”) and identified that listing the June 2018 contract month of the Contracts may impact the following Core Principles:

- **Availability of General Information** – The Exchange shall publish on its website information in regard to futures contract specifications, terms and conditions, and any changes to the delivery procedures.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the listing of the June 2018 contract month of the Contracts complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
