New York Mercantile Exchange, Inc. (“NYMEX” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying the expansion of the contract month listing schedule of the Australian Coking Coal (Platts) Low Vol Futures contract, which is listed for trading on the NYMEX trading floor and CME Globex and for submission for clearing through CME ClearPort, effective on Sunday, March 8, 2015 for trade date Monday, March 9, 2015.

The product title, symbol, rule chapters, current listing schedule and amended listing are set forth below.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” or “Act”) and identified that the amendments may have some bearing on the following Core Principles:

- Availability of General Information: The Exchange will publish information on the change via a Special Executive Report to notify the marketplace of this amendment and through an amended listing schedule which will be available on the CME Group website.
- Daily Publication of Trading Information: The Exchange shall make public daily information on settlement prices, volume, open interest, and opening and closing ranges for actively traded contract on the contract market.
- Execution of Transactions: The existing futures contract is dually listed for trading on CME Globex and the NYMEX trading floor and for clearing through the CME ClearPort platform.

Pursuant to Section 5c(c) of the CEA and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendment to the listing schedule of the Australian Coking Coal (Platts) Low Vol Futures contract complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
