Updated Live Cattle Country of Origin Affidavit

Effective immediately, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") will update the mandatory delivery affidavit ("Affidavit") attesting that all cattle tendered for Live Cattle Futures delivery (Rulebook chapter 101; Clearing Code: LC; CME Globex Code: LE) were born and raised in the United States.

The affidavit is being updated to reflect that beef no longer is a covered commodity subject to Country of Origin Labeling ("COOL") requirements. CME will maintain a U.S. origin only specification for cattle due to a lack of available public information or consensus within the beef cattle industry on the accepted valuation for slaughter cattle of non-U.S. origin. CME will continue to engage the industry on this matter.

It is important to note that no amendments are being made to CME rulebook chapter 101 ("Live Cattle") with regard to the delivery procedure for cattle. CME will continue to allow only U.S. origin cattle to be delivered per CME Rule 10101.

For your convenience, the updated Affidavit is provided below.

The Commodity Futures Trading Commission ("CFTC") will be notified of the updated Affidavit during the week of February 22, 2016, via the weekly notification procedures set forth in Part 40 of the CFTC Regulations.
