Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions effective during the week of March 2, 2020.

Effective March 6, 2020, the Exchange approved the application of Burwell Livestock Market II, LTD for an increase in their approved Livestock Yard’s maximum daily live delivery limit at their Burwell, NE location.
