RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for the Week of March 7, 2016 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily US SmallCap 2000 binary contracts on March 8, 2016, and returned to its regular listing schedule for these contracts on March 9, 2016. Additionally, Nadex added strike levels on a discretionary basis in its Daily Gold Binary contracts on March 9, 2016. Nadex returned to its regular listing schedule for these contracts on March 10, 2016. Nadex added additional strike levels on a discretionary basis in its Daily US SmallCap 2000, US Tech 100, and Wall Street 30 Binary contracts on March 10, 2016. Nadex returned to its regular listing for all contracts on March 11, 2016.

Additional strikes are attached hereto in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
