RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for the Week of March 13, 2017 - Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added strike levels on a discretionary basis in its Intraday 12pm Expiration Gold Binary on March 14, 2017. Nadex returned to its regular listing for these contracts on March 15, 2017. Additionally, Nadex added discretionary strike levels due to volatility in the underlying markets on March 15, 2017 in its Intraday 4pm Expiration EUR/USD, AUD/USD, GBP/USD, USD/JPY. Nadex returned to its regular listing for these contracts on March 16, 2017. Finally, Nadex added discretionary strike levels in its Intraday 11am Silver Binary contracts, and in its Intraday 1pm AUD/JPY Binary contracts. Nadex returned to its regular listing for these contracts on March 17, 2017. The specific added discretionary strike levels are attached in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
